INTRODUCTION OF THE UNIVERSITY

The firstever female university was established in accordance with the Frontier Women University Act 2004, passed by the Provincial Assembly and assented by the Governor Khyber Pakhtunkhwa on 7th February, 2005. However, according to the revised Act (Khyber Pakhtunkhwa Act No. XI 2010), passed by the provincial assembly of Khyber Pakhtunkhwa on September 6, 2010, the University was renamed as Shaheed Benazir Bhutto Women University (SBBWU). The University is destined to be a leading public sector Women University to impart education to the female population of this region in order to develop scientific, socio cultural, economic and political stability, through learner centered teaching and research, while strengthening the identity of the students at national and international level.

Shaheed Benazir Bhutto Women University has been functioning since 2005. 1.2 ACADEMIC ACTIVITIES:

1.2.1 SBBWU First Convocation Ceremony:

The first convocation of SBBWU was held on 28th March 2012. Where degrees were conferred upon a total of 213 graduates of SBBWU. Masters of Science degree was conferred upon 154. 

The contents of FWU Journal of Social Sciences are also indexed / abstracted in pro Quest, an online service through its social sciences Module.FWU Journal of Social Sciences is also included in EBSC' Library products, the Journal is also available online at www.sbbwu.edu.pk.



12.3 RECURRING BUDGET

EXECUTIVE SUMMARY

Revised budget for the year 2012-2013 and budget estimates for the year 2013-2014 have been prepared in the light of 20% increase as Adhoc Relief Allowance and Revision of conveyance allowance of officials announced by Government w.e.f 01.7.2012, shifting of various departments to Larama Campus & great shortfall in Receipt from Federal Govt./HEC as Grant in Aid during 2012-2013.

The revision also necessitated due to increase in number of students enrollment on a/c of commencement of new departments at permanent campus (Larama) including M.Phill/Ph.D Program.

In order to have an idea of estimated figures, head wise actual for the income and expenditure have also been given for the year 2011-2012. An overview of the actual for the year 2011-2012 is being presented briefly as below.

1. C OVERVIEW OF THE ACTUALS FOR THE YEAR 2011-2012.

A sum of Rs.76.39 million as grant in aid was received from the Federal Government through the Higher Education Commission during 2011-2012 for day to day expenses of University. In

addition to this, a sum of Rs.0.225 million was also received from HEC. A sum of Rs.125.212 million was received from the University's own resources on Account of Admission fee, Tuition fee, Hostel fee, Examination fee etc. The actual expenditure of Rs.211.056 million during the year comprised of Rs.75.897 million as salaries of staff/faculty/officers and Rs.135.159 million on utilities and other contingent expenditures. However, using strict financial discipline and control on unnecessary expenditure, the year 2011-2012 was closed with a balance of Rs.33.89 million. 2. REVISED BUDGET ESTIMATES FOR 2012-2013

The financial year 2012-2013 was started with an opening balance of Rs.33.899 million. An amount of Rs.300.00 million as Grant in Aid was expected during the year from Federal Govt. but only Rs.110.321 million has been approved by HEC for the year 2012-2013, which caused a great short fall during this year. An amount of Rs.10.146 (m) was also received as a supplementary grant from HEC regarding 20% increase as adhoc relief allowance by Govt. during the year 2012-2013. On the basis of this short fall every effort is being made to minimize the expenditure from Rs.337.26 million to Rs.228.409 million in revised estimates. An amount of Rs.74.043 million is expected to be received in the shape of University's own resources as revised estimates. The revised estimated expenditure of Rs.228.409 million is comprised of unavoidable expenses of Rs.106.84 million on account of Salary and Rs.121.568 million on account of Contingent expenses and Utilities bills. 3. A Glance at the Budget Estimates for the Year 2013-2014

An amount of Rs.329.00 million has been demanded as grant-in-aid from Federal Government through Higher Education Commission to control the serious alarming situation in the said year & to meet salaries expenses, contingent expenditure and other unforeseen charges during 2013-2014 as a result of shifting to Larama. Income from University's own resources is expected to be Rs.94.703 million. The main source of income would be admission fee, tuition fee, examination fee, hostel charges etc. The estimated expenditure of Rs.423.703 million includes Rs.197.498 million on salaries of the staff/faculty/officers against the revised expenditure of Rs.106.841 million during 2012-2013. It has also a provision of Rs.226.205 million for utilities and contingent expenditure. The increase in expenditure is due to the settlement of permanent campus at Larama, opening of new Academic Departments and increase in students' enrollment. On the contingent side, the increase is mainly due to inflation in the prices of commodities, increase in the rates of utility bills and purchase of books, physical assets, other Lab. equipment etc. The budget estimates for the year 2013-2014 can thus be summarized as below:

• DONOR SCHOLARSHIPS:
