

# Guidelines for the Constitution of Student Society in Shaheed Benazir Bhutto Women University. Peshawar.

Article I. Name: The name of the society.

**Article II. Location:** The office of the society shall be on the campus of the Shaheed Benazir Bhutto Women University Peshawar.

Article III. Rationale of Society.

Article IV. Aims and Objectives

#### **Article V. Membership**

- 1. All Shaheed Benazir Bhutto Women University Peshawar students may apply for society membership.
- 2. All the society's office bearers will have to be students at the Shaheed Benazir Bhutto Women University Peshawar.
- 3. All memberships are for the duration of one year only.
- 4. All office bearers will be subject to a performance review at the end of the year. Office bearers who have not performed well will not be allowed to continue/apply for a post next semester.
- 5. Office bearers will be elected through Elections by the Patron of the society.

#### **Article VI. Role and Responsibilities of Cabinet Members**

- 1. The cabinet of Shaheed Benazir Bhutto Women University Peshawar shall consist of:
- (a) President
- (b) Vice –President
- (c) General Secretary
- (d) Finance Secretary
- (e) Co-ordinator
- (f) Member
- 2. The Patron of the society will guide its activities and ensure that it is functioning properly.
- 3. The President shall be from BS-VII Semester or MS/MPhil/Ph.D. and will serve as the executive head of the society. In this capacity, she presides over the various committees and supervises the activities of the office bearers/members.
- 4. The vice-president shall be from BS V, VII Semesters or MS/MPhil/Ph.D. and will serve as the deputy executive head of the society, advising and assisting the President on project-related, administrative, and financial matters. In the absence of the President, the Vice-President shall assume his/her responsibilities temporarily.

- 5. The General Secretary shall be from BS/MS/MPhil or Ph.D. and is responsible for drafting documents and applications, handling correspondence, keeping a record of meetings/events, and aiding the committees in discharging the legal administrative aspects of their duties.
- 6. The Finance Secretary should be from BS/MS/MPhil or PhD and is responsible for handling membership records, advising the society on financial matters, keeping records of receipts and returns, and aiding the committees in discharging the financial/administrative aspects of their duties.
- 7. Senior cabinet members, being the representatives of their respective societies, will advise the society on matters related to project selection and involvement.
- 8. The coordinators shall be from each semester of all Departments and will assist in the implementation of projects and make sure that everyone is aware of the activities of the society.
- 9. Members can be from any semester and will be appointed by the president and assist the society in the execution of its plans.

### Article VII. The General Body

- 1. The office bearers and members shall constitute the General Body.
- 2. The General Body meets at least once a month to review progress, discuss projects and give fresh ideas.

#### **Article VIII. Committees**

- 1. The **Management Committee** will include the Patron, President, Vice-President, General Secretary, and Finance Secretary. This committee shall consist of:
- (a) Table/pass/approve resolutions pertaining to the activities of the society.
- (b) Be empowered to set up new committees as the need arises.
- (c) Monitor the activities of other committees.
- (d) Oversee the implementation of proposals of the General Body.
- 2. The **Finance Committee** will include the Patron, President, Vice-President, and the finance secretary. This committee shall consist of:
- (a) Operate the bank account
- (b) Maintaining the membership records
- (c) Keep a record of all receipts and returns.

#### Article IX. Methodology:

- i.Coordination with Vice Chancellor / Registrar
- ii.Coordination/discussion with the Director Student Affairs.
- iii. Establishment of society after formal approval by the Head of the Institution/Vice-Chancellor.
- iv.Designing and implementing a co-curricular & extra-curricular syllabus in line with the objectives of the society.
- v.Enabling and encouraging the conceptual implementation through Co-curricular & extra-curricular activities by active participation and maximum coverage.

Article I. Name: Blood Donation Society. Patron: Dr. Sadia Butt. Assistant Professor.

**Article II. Location:** Academic Block 5, 1<sup>st</sup> floor, main campus, Shaheed Benazir Bhutto Women University Peshawar.

#### **Article III. Rationale of Society:**

The Rationale of this society is to setup a system which is beneficial to people who are in need of blood due to medical emergencies. It has been noticed that usually it takes a lot of time to find a person with the required blood group, the normal process or practice is to call or text people in family or friends for help who then call or text other people in order to find the desired blood group.

The mission is to perform a critical role in healthcare by providing a safe, secure and cost effective supply of quality blood products. Blood Donation Society will be recognized for saving and improving lives in our community with safe and reliable blood donations.

# Article IV. Aims and Objectives:

The aims and objectives of Blood donation societies are:

- 1. To create awareness of donating blood and conducting health awareness programs campus.
- 2. To motivate students to donate blood.
- 3. To maintain a record of our students for blood donation.
- 4. To connect needy with volunteer blood donors.

# Article V-Article IX...... Common for all societies

#### **Article X. Code of Conduct for Blood Donation Society:**

i.Blood donation will be voluntary and non-remunerated. A donation is considered voluntary and non-remunerated if the person gives blood, of his/her own free will and receives no payment for it, either in the form of cash, or in kind which could be considered a substitute for money. This would include

- time off work other than that reasonably needed for the donation and travel. Small tokens, refreshments and reimbursements of direct travel costs are compatible with voluntary, non-remunerated donation.
- ii.Any form of incentive that might influence the underlying reason to donate blood should be actively discouraged and must be prohibited if this will either impact on the safety of the blood, result in exploitation of the donor or lead to inequity of access for recipients
- iii. The ability to donate should not be unnecessarily restricted and blood donation criteria should not be justified on the basis of gender, race, nationality, religion, sexual orientation or social class.
- iv.No coercion should be made on the donor to give blood.
- v.Blood and blood products should be considered as a public resource. Access to the products should be based on clinical need taking into account the overall capacity of the local health system. Discrimination based on factors such as patients' resources should be avoided.
- vi.Wastage of blood should be avoided in order to safeguard the interests of all potential recipients and the donor.

#### **Article XI. Suggested Activities / Functions (Event Calendar):**

- **i.**Blood camps will be arranged round the year preferably from September to May or in case of an emergency.
- **ii.**Functions like certificates/award distribution ceremony will be conducted after every blood collection drive.
- iii. Awareness seminars/hands on training, hospital visits will be organized.
