- Technical Bids will be opened on same date at 11:30 am in the Committee Room, whereas Financial Bids will be opened after completion of technical evaluation.

The prospective firms/contractors shall provide:

- Valid Registration with PEC (having relevant codes), Khyber Pakhtunkhwa Revenue Authority (KPRA), and any other relevant councils/organizations.
- Details of similar nature of projects/work (equal or greater amount) executed and in hand indicating Project Cost, Scope of Work, Inception date, and completion date with verified /attested documents from the client.
- Details of construction equipment, tools, plants, and machinery available with the firm/Contractor with verified ownership documents and indicate yearly increase.
- Full bio data List of Technical staff available with the firm/contractors showing proof of their engagement with the firm with fresh attestation/proofs.
- To substantiate the financial soundness of the firm, Bank Certificate and Bank statement clearly indicating credit worth of the firm/contractor, copy of up-to-date balance sheet and verified audit report may be furnished.
- Undertaking on judicial stamp paper that the firm has never been blacklisted by any of the Govt/semi Govt organization.
