RULES REGARDING CHANGE/CORRECTION/ADDITION/DELETION OF
NAME/FATHER'S NAME

1. (i) When a student wishes to have her name as originally entered in the University record changed, she shall proceed as under:-
 - (i) She shall apply to the Controller of Examination, Frontier Women University Peshawar through the Principal/University Teaching Department concerned, who originally sent up her name, paying a fee of Rs.200.00 and in case of unregistered and private students (except Late College Student) by Chairman of Union Council.
 - (ii) She shall supply as press cutting of the Notice of change of name in at least one daily News Paper.
 - (iii) She shall support her application with an affidavit duly sworn before 1st Class Magistrate/Oath Commissioner (by the candidate himself) with signatures of two respectable witnesses thereon.
- (b) When a student wants to get her name corrected (this will include addition alteration or other minor modification not basically affecting the name). She shall be required to comply with item No. 1 (a) above. If a candidate whether registered or unregistered (only those unregistered candidates who passed their Matriculation Examination from this University) wishes to have her father's name corrected shall in addition to item i. ii. iii. of regulation 1, above get her application endorsed by the Chairman of Union Council concerned.

NOTE: 1. Change in father's name is not allowed in any case.
