5. After the completion of BS-4 years final term exam, Spring semester of BS 2<sup>nd</sup>, 4<sup>th</sup> and 6<sup>th</sup> semester will be conducted online w.e.f 29<sup>th</sup> March, 2021.
6. BS-8<sup>th</sup> semester of all programs will be conducted physically on campus w.e.f 29<sup>th</sup> March, 2021.
7. The classes of MS/M.Phil/Ph.D will be conducted online from 15/03/2021 to 28/03/2021.
