





As required under Section-14 of the "Shaheed Benazir Bhutto Women University Peshawar Election to the University Authorities Statutes, 2016", the nomination papers for the above mentioned constituencies will be **scrutinized** by the Returning Officer on 15.11.2021 up to 2:00 pm in the Academic Section. The candidates or their election agents, proposers or seconders may attend the scrutiny of the papers.
3. As required under Section-16 of the "Shaheed Benazir Bhutto Women University Peshawar Election to the University Authorities Statutes, 2016", a candidate can **withdraw** his/her candidature by notice in writing signed by him/her and deliver to the Returning Officer himself/herself on 17.11.2021 or by Registered Post so as to reach the Returning Officer on the date as mentioned above. Any notice of withdrawal shall in no circumstances be open to revocation or cancellation.
4. Elections shall be held on 01.12.2021 (*S. No 12 of the Notified Elections -2021 Schedule*) from 9:00 am to 2:00 pm in the Main Campus, Shaheed Benazir Bhutto Women University, Peshawar.
