- 3. Technical design should be based on proper analysis and rates should be quoted accordingly in the bid.
- 4. Registration with FBR and on the Active Tax payer list (ATL).
- 5. Registration with Khyber Pakhtunkhwa Revenue Authority (KPRA) and Sale Tax.
- 6. In case of bid more than 10% below, the bidders shall submit additional bid security as per KPPRA rules.
- 7. Financial Bid must be accompanied by Bid security in shape of call deposit @ 2% of the Engineer Estimate in the name of Treasurer, SBBWUP.
- 8. Income tax returns for last 03 years / audited reports.

- 6. Original Affidavit on Stamp Paper that the Firm DOESN'T have any Litigation History in which Decision has been given against the firm(s). (If Applicable) Joint Venture agreement as per PEC criteria on stamp paper, signed by authorized persons of all the firms should be provided.
- 7. The defect liability period is 01 year for all allied accessories & the warranty period for solar panels is 25 years shall be commenced from the date of commissioning.
