



- 3) In light of the above under your kind directives, we have floated the AAA internet Policy Circular in the University attached as ANNEXURE- B, An Ex-Post facto approval is also solicited for the said circular.
- 4) To implement the policy we will be needing the following on regular basis:
 - a) Provision of Enrollment/Registration numbers of the Students with their Department and session from Admission section and Directorate of Advance Studies and Research as and when required.
 - b) Provision of Information by the Coordinator/Incharge of Department to IT Centre through official medium about the students, who fail to promote, leave University, migrate, completed their session or as and when required. Any of the illegal usage by any not reported or those students who left University would be the sole responsibility of the Coordinator of the Department.
 - c) Establishment Section will inform IT Centre about the employees who are missing or leave the University, so that their names should be removed from Email and Internet users' database to avoid unauthorized activity.
- 5) An approval for issuing an office order is required for promulgating the said responsibilities through Registrar office to Establishment^{Section} and all In charge of the Academic Departments. For your kind perusal and orders, Please.
