  - ii. BS-8<sup>th</sup> semester
  - iii. Final year Research/Project students
  - Lab-based students or those having requirement of laboratory work for BS and iv. Masters program
  - v. Students having internet connectivity issues, as per the details provided by the Incharges of each Department.
- 2. The classes of MS/M.Phil/Ph.D will be conducted physical from 09/08/2021 onwards with proper SoPs.
- 3. The online classes of BS- 4 years program (2<sup>nd</sup>, 4<sup>th</sup> , 6<sup>th</sup> semesters) and Masters (3<sup>rd</sup> semester) will continue with effect from 9th August, 2021 as per their respective Departmental Schedule.
- 4. Hostel is reopened for the registered hostel students for the following categories w.e.f 9<sup>th</sup> August, 2021;
  - i. MS/M.Phil/Ph.D students of all departments
  - Masters 1<sup>st</sup> Semester of all departments ii.
  - BS-8<sup>th</sup> semester of all departments iii.
  - Final year Research/Project students of all departments iv.
  - Lab-based students or those having requirement of laboratory work for BS and v. Masters program
  - Students having internet connectivity issues, as per the details provided by the vi. Incharges of each Department
