Course Title: Fundamentals of Political Science	Course Code: PSC-301

Course Description: This course provides an introduction to Political Science, covering its definition, nature, scope, and sub-fields. It explores the relationship with other social sciences, approaches to study, and key concepts like power, authority, and legitimacy. The course also examines the state, nation, sovereignty, and the organs of government: legislature, executive, and judiciary.	
Course Objectives: The objectives of this course are 1. To introduce the students with the fundamentals of the subject of Political Science and prepare them for advanced studies in the forthcoming semesters. 2. The very basic concepts and terminology commonly used in the further courses of studies are taught to make the students friendly with the subject.	
Course Outline: Definition, Nature, Scope and Sub-fields of Political Science, Relationship of Political Science with other social sciences, Approaches to the study of Political Science: Classic/Traditional and Behavioral Approach, State: its origin and evolution, Nation and Sovereignty, Basic Concepts of Political Science: Power, Authority, Legitimacy, Organs of Government: Legislature, Executive, Judiciary. Note: Sub-fields of Political Science include: Political Philosophy/Theory; Comparative Politics; International Relations; Public Administration/ Public Policy; Local Government, etc.	
Course Outcomes: 1. Understand the core concepts and sub-fields of Political Science. 2. Analyze the relationship between Political Science and other social sciences. 3. Evaluate the application of political theories and approaches in the current political system of the state. 4. Comprehend the political structure and functions of various governmental departments and organs.

Course Title: Theories of Origin of State	Course Code: PSC-307
Course Structure: Lectures: 3, Labs: 0	Credit Hours: 3
Course Description: This course provides a comprehensive introduction to the concept of the state, examining its definition, types, and essential features. Students will explore various theories on the origin and nature of the state, including the Divine Origin Theory, Organismic Theory, Matriarchal Theory, Force Theory, Evolutionary Theory, and Social Contract Theory. The course also delves into Karl Marx's view of the state as an instrument of class rule, Friedrich Engels's perspective on the state as a product of class conflict, and Max Weber's theory of the state as a monopoly on the legitimate use of force.	
Course Objective: The course will enable students to: 1. Define the concept of the state and explain its essential features. 2. Identify and describe the major theories of state origin. 3. Analyze the strengths and weaknesses of each theory. 4. Apply their knowledge of the theories to real-world examples of state formation.	
Course Outline: Introduction to the State, What is a State? Different types of States, Essential features of the State, Divine Origin Theory, Organismic Theory of State, Matriarchal Theory as the Origin of State, Force Theory of Origin of State, The Evolutionary Theory of State, The Social Contract Theory, Karl Marx's theory of state as an instrument of class rule, Friedrich Engels's theory of the state as a product of class conflict, Max Weber's theory of the state as a monopoly on the legitimate use of force	

Course Outcomes:

The students will understand

1. The modern concept of state and its structure.
2. The detailed study of theories will enhance students understanding regarding the birth of state and better conclude the working theories of today.
3. The evolution of state and government with historical perspective.

Course Title: Political Institutions, Processes and Practices	Course Code: PSC-302
Course Structure: Lectures: 3, Labs: 0	Credit Hours: 3
Course Description: This course explores various forms of state and government, including unitary, federation, and confederation states, as well as parliamentary and presidential forms of government. It covers the definition, characteristics, and functions of political systems, political parties, and interest groups. Students will learn about public opinion, its formulation and assessment, and the electoral process, including mechanisms, types of representation, and requirements for impartial elections. The course also delves into political ideologies such as liberalism, fascism, Islamism, socialism, Marxism, and nationalism. Additionally, it examines concepts like national integration, globalization, governance, feminism, terrorism, political exclusion and inclusion, and power sharing.	
Course Objective: The students are to be enabled to understand 12. The functional aspects of the politics in a society.	

13. Functioning of the political system and study its various components and actors influencing this functioning.
14. The conceptual framework of political parties and pressure groups and their role in shaping and reshaping of public opinion.
15. The process of election and kinds of representation.
16. The philosophical discourses of different political ideologies, and emerging trends in politics.

Course Outline:

Forms of State: Unitary, Federation, Confederation, Forms of Government: Parliamentary, Presidential, Political System: Definition, Characteristics and Functions, Political Parties: Kinds, Structures, Functions, Interest Groups: Kinds, Functions, Relationship with Political Parties, Public Opinion: Definition, Formulation, Assessment, Electoral Process: Mechanism, Kinds of representation, requirements of impartial elections, Political Ideologies: Liberalism, Fascism, Nazism, Socialism, Marxism, Nationalism, National Integration, Emerging political concepts and terminologies: globalization, governance, feminism, terrorism, political exclusion and inclusion, power sharing.-

Course Outcomes: On completion of course the students will be able

1. To differentiate among various kinds of state and government,
2. The political power sharing and the working machinery of government.
3. To better understand different state structure in the contemporary world.

Course Title: Basic Political Ideologies	Course Code: PSC-308
Course Structure: Lectures: 3, Labs: 0	Credit Hours: 3
Prerequisites: F.A / F.Sc with at least 45% marks	
Course Description: This course offers an in-depth exploration of various political ideologies	

and their impact on society. Students will examine the concepts of nationalism, conservatism, socialism, communism, capitalism, liberalism, fascism, feminism, environmentalism, and ecologism. Additionally, the course will explore into Islamic ideology and its perspective on society. Through this course, students will gain a comprehensive understanding of these ideologies, their historical development, core principles, and their influence on contemporary political and social structures.

Course Objective: The course will enhance students understanding regarding;

1. Introducing basic concept of political ideologies, their role in shaping political systems and setting grounds for international politics.
2. Familiarizing students with key political ideologies, their source/origin and their major proponents.
3. Enhancing critical thinking by inspecting strengths and flaws of various political ideologies.
4. Providing students with understanding of impact of certain political ideologies on political systems and policies.
5. Exploring practical implantation of political ideologies in contemporary societies and politics.

Course Outline: Concept of Political Ideology, Nationalism , Conservatism, Socialism, Communism, Capitalism, Liberalism , Fascism, Feminism, Environmentalism, Ecologism, slam Ideology and Islamic view of Society.

Course Outcomes: At the completion of the course students will be enabled to

1. Get basic and essential understanding of key Political ideologies.
2. The political ideologies taught have shaped and impacted political scenario historically till contemporary times.
